Michael Cirami is a vice president of **Eaton Vance Management** and co-portfolio manager of Eaton Vance Emerging Markets Income Fund, Eaton Vance Global Macro Absolute Return Fund and Eaton Vance International Income Fund. Michael joined Eaton Vance's Global Fixed Income Department in 2003. Previously, he was employed at State Street Bank in Boston, Luxemburg, and Munich, and with BT&T Asset Management in Zurich. Michael earned a B.S. in Business Administration and Economics, cum laude, from Mary Washington College and a M.B.A. with honors from the William E. Simon School at the University of Rochester. He is a Chartered Financial Analyst and a member of the Fixed Income Management Society of Boston and the Boston Security Analysts Society.



Chris Derksen is the Head of Frontier Markets at **Investec Asset Management** where he is responsible for all strategies related to listed and private equity investment in Africa (ex SA) and the Middle East. In addition, he is an investment principal of the Investec Africa Private Equity Fund.
